### General Comments

1. Braille pages are numbered sequentially in the lower right-hand corner. The corresponding print page numbers are in the upper right-hand corner.
2. A Special Symbols page is included to provide the student with information about the dot formation of special braille characters. A Transcriber's Note page is included within the test to explain special format and layout of information.
3. This test is transcribed according to *Braille Formats: Principles of Print-to-Braille Transcription, 2011*.
4. This test is transcribed according to *The Nemeth Braille Code for Mathematics and Science Notation, 1972 Revision, 2007-2013 Updates*.
5. The footers "Go on" are deleted in braille.
6. All references to the answer sheet are omitted in braille. The Answer Sheet is not reproduced in braille.
7. The calculator icons are not included in braille.
